Dear Candidate,

We wish to inform you that you are provisionally selected for admission to the MBA programme 2015-2017. In order to confirm the provisional admission (6th round), you are required to pay one semester's fee (OC/OBC = Rs. 58,300 and SC/ST Rs. 8.300) through State Bank of India online SBcollect (https://www.onlinesbi.com/prelogin/institutiontypedisplay.htm) during the period between 26th May, 2015 and 1st June 2015. Admissions for students in the waiting list would get operated immediately after the last date of 6th round of provisional admission.

Please note the following points:

- 1. Request for change in the mode of payment or extension of the dates will not be entertained.
- 2. You will be required to bring all the original certificates as specified below for verification at the time of admission on 13th July, 2015 and submit the original Transfer certificate and Degree certificate along with the attested photo copies of all the certificates for our records.
 - Statement of Marks or Grades obtained in the qualifying examination.
 - Degree/Provisional Certificate.
 - Transfer Certificate.
 - Course Certificate. Conduct and Character Certificate.
 - Students who are awaiting their results should submit their degree and final year marks statement on or before 14th August, 2015.
 - S.S.L.C. or any other Certificate for proof of age.
 - Physical fitness certificate certified by a Government Medical Officer.
 - Community Certificate for candidates selected under OBC/SC/ST Category (OBC Certificate should have been issued on or after 01.04.2015 as per the norms of Central Government of India).
 - The format for Non creamy layer OBC certificate dated on or after 01.04.2015 for OBC candidates is available at the end of this communication.
 - CAT Score Card.
- 3. The advance payment of one semester fee is mandatory to confirm your seat and in case of any cancellation of your seat you need to claim the advance payment by submitting proper proof (e.g., SBcollect online payment slip and

SBcollect reference number). If any candidate fails to pay their one semester fee through SBcollect within the stipulated time, his/her candidature is automatically cancelled and he/she cannot claim for admission to MBA programme.

- 4. Candidate provisionally selected under PWD category will have to be approved by the Medical Board as per NITT norms.
- 5. After making the advance payment, if you wish to cancel your seat, you need to formally send an email communication to mbaadmissions@nitt.edu with the required particulars and refund will be made after detecting a penalty as per the norms of the institute.
