Dear Members,

It is my privilege to present the annual report covering the activities of RECAL for the year 2015-16.

Beyond Golden Jubilee

Our Golden Jubilee celebrations and multi US city visit by Office Bearers and Director of the previous years have set a stage of increased Alumni involvement with the alma mater. Apart from the traditional Silver Jubilee (25 year) celebrations in the Campus of the respective batches, alumni meetings such as 10 years, 40 year reunions of few batches in the campus were held. We thank the Institute administration for facilitating the same. The RECAL office at the campus is staffed by a full time Manager, Mrs Vani RT who manages the day to day activities and co-ordinates with all the stakeholders.

We are also delighted to note that many of them also made significant contributions, directly or indirectly to the Campus – such as IOT lab by 1981 batch, Innovation centre by 1990 batch and significant corpus contribution by 1974 and 1976 batches to RECAL Foundation for providing scholarships.

RECAL Foundation

As you may be aware, five of the elected office bearers of RECAL Association serve as Trustees in RECAL Foundation. RECAL Foundation is a not for profit Trust and is the principal vehicle to utilize contributions from Alumni. RECAL Foundation has approvals from FCRA for receiving foreign contributions. The Foundation has also tied up with CAF America, that enable contributors residing in US to get a tax benefit. Both the routes are active and the RECAL Foundation has been receiving regular contributions from time to time. RECAL Foundation has received over Rs 60 lakhs in corpus for scholarship purposes to be issued from the Interest received annually.

Social Initiatives

RECAL Association also provided monetary support for the flood relief activities in Tamil Nadu through student initiatives. Bangalore chapter has over the last years championed a few social with the key initiative being 'Under the stars' event that they run during DaanUtsav (India's festival of giving). Other chapters are encouraged to engage in similar activities to enhance brand NIT Trichy.

Chapter Activities

The Bengaluru chapter conducted a Welcome meet for the new Alumni in April 2016. The Chennai chapter conducted an Alumni meet in June 2016 along with Distinguished Alumni Award function and farewell send off to Dr Srinivasan Sundarrajan who retired as Director after completing eventful five year term. In addition to above activities by the Chapters, special groups focused on entrepreneurs meet at regular frequency in various cities.
