Change of State of Eligibility / Category

The Central Counselling Board -2011 (CCB-2011) has initiated a process for correction of erroneous entries that the candidates might have made while filling the AIEEE application form. The entries pertaining to “**State of Eligibility**” and “**Category**” of the candidates will have an important bearing on the seat allotment process under CCB-2011. Hence, if required the Candidates are being provided with this **one time opportunity to correct the erroneous entries** before the start of the central counselling process. Candidate desirous of such corrections are requested to submit the documents as given below:

(i) State of Eligibility:

For correcting the “State of Eligibility”, candidates have to submit details & certificate of the school / college where they have registered and studied for the qualifying examination. The certificate should be duly signed by the Head of the school / college on official stationary

(ii) Category:

For correcting the “Category” status, the candidates have to submit the latest category certificate issued by the competent authority along with a notarised / attested copy of the same. The attestation should be done by a Gazetted officer only.

Candidates seeking corrections have to appear personally with the duly filled & signed proforma, with all the relevant original documents and their notarised / attested copies, at any one of the locations as per details given below.
