The queries raised by the bidders and answers given by the NITT are narrated below:

Q 1. Is there restriction on paying more than the prescribed minimum wages bidding agency?

Ans: NITT will pay statutory minimum wages only. However, there is no restriction on the part of successful bidder to pay more than the prescribed statutory minimum wages.

Q2. Whether the institute will provide stationary for log (Log Book) the events?

Ans: Yes. The institute will provide stationaries on need basis.

Q3. Who will take care of the repairing charges?

Ans: NITT will take care of the repairing charges i.e. Original Equipment services not included in this tender.

Q4. Whether the institute will provide subsided food /Accommodation to the bidders labourers?

Ans: No. Subsided food /Accommodation will not be provided to any persons.

Q5. Whether NITT provides basic tools for operation and maintenance?

Ans: No.The NITT will not provide any basic tools. The Successful bidder shall have to arrange basic tools (including personal protective safety devices) at their own cost.

Q6. Whether any vehicle provided by the NITT?

Ans: No. NITT will not provide any vehicle.

Q7. Is any revised technical and price bid format will be provided?

Ans: Yes. It is published along with this pre bid minutes.

Q8. Whether the bidder shall have to obtain and produce license under the Contract Labour (Regulation & abolition Act 1970) from the labour department?

Ans: Yes. The bidder should obtain and produce the license under the Contract Labour (Regulation & abolition Act 1970). In case, if the bidding agency is not attracted by provisions of the said Act, the fact should be brought out clearly in the Technical bid along with the reasons.

After clearing the doubts raised by the bidders, the committee members are decided to modify the tender in respect of the following:

Amendments:

- 1. **Pre-qualification criteria**: The bidding agency shall have a valid EA license and experience in Electrical installation and maintenance.
- 2. **Annual Turn Over**: The bidding agency shall have annual turnover not less than Rs 15.41 lakhs (80% of the estimated cost) in the last two years or three years or single year
- 3. Revised Technical bid and Price bid are given in the succeeding pages.

- 1. All columns are mandatory and, therefore, no row should be left blank .if no charges are applicable, clearly state zero in the row.
- 2. The minimum Wages given in the row is, as on 1st April 2015. Variation in minimum wages due to variable clearness allowance as and when notified by the government will be reimbursed by the NITT. Similarly, other statutory increase will also be considered.
