01.	<p>Providing Wooden flooring using second class teak wood with the following specification.</p> <p>(1). The primary frames of country wood with the size of 45mm x 45mm placed at an interval of 450mm centre to centre with 45mm x 70mm x 13mm Nitrele Resilient pad fixed on the bottom using screws.</p> <p>(2).The secondary frame of country wood of sizes 45mm x 45mm is placed at an interval of 450mm centre to centre diagonally on the primary frames and it is firmly fixed with necessary imported self threading screws.</p> <p>(3). Over the runners 20mm thick Tongue & grooved 2nd quality Teak wood flooring planks of sizes 1 feet to 8 feet length and width of 70mm to 125mm using imported flooring nails (L cleats) and adhesives.</p> <p>(4).The above floor is leveled with drum sanders with 3 grits like Rough, Medium and Nice and polished with imported polyurethane.(One coat seale and two coats of top coat and one coat of Antislip). The rate including cost of all materials and labour charges etc as per the direction of Engineer-in-charge.(The gap between scantling shall be filled with C.C.1:2:4 by departmentally).</p>	99	Sqm
