National Institute of Technology (NIT), Tiruchirappalli invites Expression of Interest from the interested nationally / internationally reputed Indian Organizations to run a new CBSE based **Campus School** in the Institute campus for the benefits of the children of residents as well as residents nearby area of the Institute.

### **About NITT**

The National Institute of Technology (formerly known as Regional Engineering College) Tiruchirappalli, situated in the heart of Tamil Nadu on the banks of river Cauvery, was started as a joint venture of the Government of India and the Government of Tamil Nadu in 1964 with a view of catering to the needs of man-power in technology for the country. The National Institute of Technology (formerly known as Regional Engineering College) Tiruchirappalli, offers Under Graduate Courses in ten branches and Post Graduate Courses in twenty one disciplines of Science, Engineering & Technology besides M.S. (by Research) and Ph.D. in all the departments. There are 18 boys' and 5 girls' hostels in which 5320 undergraduate and postgraduate students are accommodated. ### **Eligibility Criteria**

1. A recognised National / International level reputed Institution / Organisation having motto to serve the society.
2. Experience in successful running Co-Educational Schools from Nursery to XII standard under the CBSE Syllabus for not less than 2 decades with the strength of more than 1,200 Students.
3. Proven track record of quality education in terms of 80% and above success in CBSE exams.
4. Should be running schools atleast in four States in the country.
5. Should have a central controlling unit to Monitor and Co-Ordinate functioning of their schools.
6. Should have ability to provide a creative environment which is both stimulating and challenging in order to improve the skills.

### **Infrastructure to be provided by NIT, Tiruchirappalli**

1. Permanent School buildings with full furnished class rooms.
2. Playground facility.
3. Round the clock security in the campus.
4. Limited housing accommodation, on request, if available, as per norms for Staff / Teachers.
5. All facilities like supply of drinking water through overhead tank, electricity, power backup on payment of actual consumption.

NIT, Tiruchirappalli will only have a limited role, ensuring quality education and appropriate fee structure for all the students. However, the fee structure for the Students of the residents of the NITT may be fixed at par with K.V. School.

## Stage 2

### **Selection Process:**

The Highest Scorer will be chosen among the applicants of EoI who are satisfying eligibility criteria by the following process.

- (a) **Weighting Factor W(i) of Applicant (i) on Success Rate** is obtained by dividing the number of students appeared CBSE exam through all schools of applicant n(i) for the past 10 years (from the academic year 2005-2006 to 2014-2015) by total number of students appeared CBSE exam through the schools of all applicants for the past 10 years. So the weighting factor of applicant (i) on success rate is given by

$$W(i) = \frac{n(i)}{\sum n(i)}.$$

- (b) **Success Rate Score R(i) of Applicant (i)** is obtained by the multiplication of sum P(i) of the success rates (No.of Passed students / No.of students appeared) of each school of applicant in the past 10 years and weighting factor of applicant on success rate W(i). So Success rate score of applicant (i) is given by  $R(i) = P(i) * W(i)$ .

- (c) **Normalisation of Success Rate S(i)** is obtained by dividing the success rate score of the applicant R(i) by total Success rate of all the applicants. So the normalised success rate of the applicant (i) is given by  $S(i) = \frac{R(i)}{\sum R(i)}$ .

- (d) **Normalised Number of Schools N(i) of Applicant (i)** will be arrived at by dividing the number of schools of applicant x(i) by total number of schools of all applicants who are satisfying eligibility criteria. So the normalised number of schools of the applicant (i) is given by  $N(i) = \frac{x(i)}{\sum x(i)}$ .

- (e) **Normalised Experience Factor E(i)** will be arrived at by dividing the number of years of experience of the applicant y(i) by total number of years of experience of all the applicants who are satisfying eligibility criteria. So the normalised experience factor of the applicant (i) is given by  $E(i) = \frac{y(i)}{\sum y(i)}$ .

- (f) **Total Score T(i) of Applicant (i)** will be the sum of Success rate score of i<sup>th</sup> applicant R(i) and Normalised number of school for i<sup>th</sup> applicant N(i).

i.e.,  $T(i) = 0.6*[Success\ rate\ score\ R(i)] + 0.4*[Normalised\ number\ of\ school\ N(i) + Normalised\ experience\ factor\ E(i)]$ .

**H1 Applicant:** The highest scorer will be the one whose **T(i)** value is the highest among the applicants who are satisfying eligibility criteria. H1 Applicant will be submitted to the BoG of the Institute for clearance.

### **Stage 3**

After getting approval of the BoG of the Institute, NITT will grant permission to run the new school in the Institute Campus subject to the terms and conditions.

#### **Note:**

- (i) In the formative years of the school, the number of students in each class may be small.
- (ii) School can avail the services of Faculty and Staff s spouses with high academic qualifications.
