- 2. The water purifier shall have S.S.body and S.S.Tap provisions.
- 3. The water purification process shall include both R.O and U.V treatment.
- 4. The treated water should be free from physical, chemical and Biological contaminants, ie fresh, pure & safe water and give unparalleled assurance of extended bio-purity cover for a full 48 hours period.
