3	Page No 05: Section C; S.No. 5	FSSAI Certification	For Tender Participation, Bidders enclose preferably Central FSSAI Certificate (s) for existing Locations. However, it must be obtained for NITTH Mess/Food Court at earliest after issue of Work Order.
