Infrastructure to be provided by Aaveg of NIT, Tiruchirappalli

1. The selected applicant will be provided with stall of one of the following sizes based on the number of items being served and the rent being paid:

1.	15 x 10
2.	10 x 10
3.	7.5 x 10

2. The applicant will be provided with required electricity and water arrangements.

Selection Process:

1. Each type of food stall vendor must submit a response to the Aaveg Core Team through E-Mail (aaveg.nitt@gmail.com) prior to the issued deadline.
2. After obtaining a quote from each type of vendor based on Cuisine/menu, the Aaveg Core Team consisting of 12 members will select the vendor based on H1 criteria, i.e., highest rent quoted for that cuisine based stall.
3. After finalizing the successful vendors for each type of stall the final list will be put to the Dean (SW) through the concerned Staff Advisor/Faculty Advisor of Aaveg along with the final menu for each stall.
4. Post the approval the food stalls will be contacted by the Aaveg Core Team. Successful vendors need to submit a DD of the quoted rent addressed to :
