1.	<p>The Chairperson, Senate, welcomed all Members to the 70th Meeting of the Senate and expressed appreciation for their continued commitment to strengthening academic standards and fostering the sustained growth of NIT Tiruchirappalli. Through collective dedication and focused efforts, the Institute continues to attain national recognition, global distinction, and successfully implement initiatives aligned with its mission of excellence and nation-building.</p> <p>The Chairperson welcomed Dr. R. Jeyapaul on assuming charge as Dean (Faculty Welfare) and placed on record sincere appreciation for the valuable and dedicated services rendered by Dr. N. Kumaresan, former Dean (Faculty Welfare). The Chairperson also welcomed the newly appointed Heads of the Departments of Physics, Chemistry, Mathematics, Management Studies, Electronics and Communication Engineering, Chemical Engineering, and Metallurgical and Materials Engineering, while expressing the Institute's gratitude to the former Heads of these departments for their commendable contributions. Newly inducted Senate Members attending their first Senate meeting were also warmly welcomed.</p> <p>The Senate was informed that offer letters had been issued to 28 new faculty members, who are expected to join shortly, thereby further strengthening the Institute's academic and research ecosystem.</p> <p>With respect to institutional performance, it was noted that sustained achievements in NIRF and QS rankings reflect the consistent and collective efforts of faculty, staff, students, alumni, and institutional partners. The Chairperson highlighted the successful conduct of the 21st Convocation on 26 July 2025, presided over by Dr. V. Narayanan, Secretary, Department of Space and Chairman, ISRO, during which degrees were conferred upon 2,045 graduates, including 175 Ph.D. scholars.</p> <p>The Senate took note of the outstanding achievements of students across academic, technical, cultural, and sports domains. These included top global rankings at the European Hyperloop Week 2025, India's representation at the ICPC World Finals 2025 for the fifth time, securing the second runner-up position at the McKinsey TechQuest, commendable performances at SportsFest 2025, and notable achievements in various Inter-NIT sports events. The enhancement of student services through the organization of a Passport Mela on campus was also acknowledged.</p> <p>It was further noted that the Institute received the National Institutional Award for Excellence in BIS MoU Implementation for effectively integrating standardization and conformity assessment into the curriculum, and that two faculty members were honoured with National Best Write-Up Awards. Alumni contributions were also acknowledged, particularly through</p>

	<p>RECALL, including the donation of advanced medical equipment worth approximately ₹67 lakh to the NITT Hospital and the establishment of new research facilities as part of the Class of 1999 Silver Jubilee celebrations.</p> <p>The Chairperson informed the Senate about the Institute's active participation in the Rashtriya Karmayogi Large-Scale Jan Seva Programme – Phase II, during which a one-day professional training programme was conducted for 533 faculty and staff members. A subsequent programme for the remaining employees is scheduled on 2 January 2026. The sincere efforts and dedication of the Master Trainers, Dr. Sreejith Mohan, Dr. S. Nivethitha, Dr. Laiju A. R., Dr. D. Kannamma, Dr. G. Thavasi Raja, Shri S. Saravanan, and Shri R. Karthikeyan were placed on record with appreciation.</p> <p>The Senate observed that these achievements collectively reaffirm NIT Tiruchirappalli's commitment to academic excellence, impactful research, innovation, and holistic development. The Chairperson expressed confidence that the continued guidance and support of the Senate would further strengthen the Institute's stature as a premier institution of higher education and research.</p> <p>The Chairperson once again expressed sincere appreciation to all Members of the Senate for their unwavering commitment and requested the Secretary to proceed with the agenda.</p>

iii.	<p>Approval of Regulations for UG, PG, and Ph.D. Programmes – 2024.</p> <p>The Senate considered the agenda item pertaining to the revision and approval of the Academic Regulations for UG (B.Tech., B.Arch., B.Sc. B.Ed.), PG, and Ph.D. programmes. It was noted that the Academic Ordinance Committee (AOC) had been constituted to undertake a comprehensive update of the academic regulations applicable to all UG, PG, and Ph.D. programmes.</p> <p>The Senate was informed that the AOC conducted four review meetings to examine the existing regulations. During the revision process, all relevant Senate-approved decisions and provisions of the earlier regulations were meticulously reviewed and duly incorporated. Following extensive deliberations, the revised Academic Regulations for UG (B.Tech., B.Arch., B.Sc. B.Ed.), PG, and Ph.D. programmes were finalized in conformity with prevailing academic standards.</p> <p>The Senate discussed the matter in detail and took note of the finalized Regulations. During the deliberations, the Senate made specific observations regarding the entry and exit provisions for UG and PG programmes, as well as the nomenclature and implementation framework of microcredit courses, and directed that these aspects be explicitly and clearly addressed in the Regulations.</p>

It was noted that the BoS of the Department of Computer Applications had reviewed and approved the proposal for offering the Online M.Tech. Programme in Data Science and Artificial Intelligence, envisaged as a Joint Degree Programme of NIT Tiruchirappalli and the Illinois Institute of Technology, USA, along with the proposed curriculum and syllabi for implementation from the Academic Year 2026-2027.</p> <p>The Senate deliberated on the proposal and was apprised of the salient features of the proposed Online M.Tech. Programme. During the discussions, the Senate observed that certain modifications were required in the existing curriculum and emphasized the need for a more comprehensive and detailed presentation covering the programme structure, delivery mode, assessment framework, and overall implementation strategy.</p> <p>Accordingly, the Senate advised that the proposed curriculum and syllabi be revised by incorporating the observations made and directed that a detailed presentation on the Online M.Tech. To provide focused academic and administrative support for teacher education programmes, ensure effective implementation of the ITEP curriculum, foster interdisciplinary collaboration, and strengthen teaching, research, and outreach activities in education aligned with national education policy objectives, a proposal for the creation of a separate Department of Education was placed before the Senate for consideration and approval.</p>	RESOLUTION 70/SENATE/2025/5/v RESOLVED THAT the proposal for the creation of Department of Education for the implementation of the B.Sc. B.Ed. Programme under ITEP, be approved.

Information Item to the Senate, by the Chairperson, Senate:

As per OM F.No.19-2/2024-TS.III dated 08 May 2025, the Ministry of Education has sanctioned an additional 212 teaching positions to the Institute, with the approval of the Department of Expenditure, Ministry of Finance, Government of India. In this context, the Institute constituted a committee to determine the optimal allocation of these additional faculty positions across various departments.

The Committee adopted the "Course Credit × Student Strength" model for faculty apportionment, taking into account factors such as the actual credits handled by each department, enrolled and sanctioned student strengths, and the number of programmes and courses offered. The analysis was based on statistical data from the academic years 2023–2024 and 2024–2025, with a proposal to maintain the existing distribution of subjects, including first-year B.Tech. courses.

The Committee also noted changes in credit requirements for UG and PG programmes over the years and made appropriate adjustments to the allocation. Specific provisions were recommended for departments offering B.Sc. B.Ed. (ITEP) courses and microcredit courses. Furthermore, the Committee recommended that the Professional Ethics course be managed by the respective departments, and accordingly, departments should assign an appropriate course code to indicate inclusion of this subject within their curriculum.
