1. The Chairman further apprised the Senate of the Institute's initiatives to strengthen international academic and industry collaborations through the signing of Memoranda of Understanding with the University of William & Mary, USA, for academic exchange and collaborative research, and with Kauvery Hospital, Tiruchirappalli, for the launch of a Postgraduate Diploma Programme in Healthcare Technology through the Department of Instrumentation and Control Engineering. She acknowledged the continued contributions and dedicated services of Dr. S. Selvakumar, Professor (HAG), Department of Computer Science and Engineering, and Dr. G. The Dean (Academic) presented the detailed statistics on Ph.D. admissions for the Academic Year 2025–26, including the department-wise distribution of admissions under various categories, for discussion by the Senate. During the deliberations, it was noted that the Institute follows a rigorous selection process comprising a written test and interview for admission to the Ph.D. programmes. The Senate further observed that the number of GATE-qualified candidates admitted during the Academic Year 2025–26 was comparatively low. Members discussed the need to ensure wider accessibility to the Institute's doctoral programmes while maintaining the quality and standards of research admissions.

After detailed deliberations, the Senate approved the proposal for granting exemption from the GATE qualification requirement for admission to the Ph.D. programmes of the Institute for all categories of applicants for the Academic Year 2026–27.

Further, to improve the Ph.D. admission process and examine the proposal for exempting candidates from the requirement of GATE/other qualifying examinations, the Senate suggested the matter may be referred to the Academic Reforms Committee (ARC) / Advisory Committee for Ph.D. Affairs for detailed deliberation. Based on the recommendations of the Committee, the proposal may be placed before the Senate for consideration and approval, with implementation from the next academic year onwards.
