**CIRCULAR**

**Sub:** Deregistration of Elective Courses with V Grade – January 2026 – Reg.

Students of B.Tech. (2022 and 2023 batches) and B.Arch. (2021, 2022 and 2023 batches) programmes who have obtained '**V grade in an elective course (PE/OE/OC)**' during the **July 2025 session** or earlier are permitted (optional) to apply for the deregistration of such courses, subject to the following:

- **Only elective courses with 'V' grade** are permitted for deregistration. Elective courses with 'X' or 'F' grade are not permitted for deregistration.
- Minors and Honors courses with 'V' or 'F' or 'X' grade are not permitted for deregistration.
- Upon deregistration, students will become **ineligible** for the award of **First Class with Distinction and Honors degree**, irrespective of overall performance (CGPA).
- Students will not be permitted to register for Contact Courses (Redo) for any course that has been deregistered.
- It is the student's responsibility to ensure that all academic credit and course requirements are met for the successful completion of the degree.
- Deregistered courses will be permanently removed from the academic transcript and will not count towards CGPA or credit requirements.
- Deregistration is not reversible once processed. Students are advised to consider the academic implications carefully and consult their academic mentor faculty before proceeding.

**Procedure for Deregistration of Elective Courses with V Grade:**

1. **Download and complete** the attached Requisition Form for deregistration of elective courses with V grade.
2. Obtain the **signature** from the concerned course faculty and the **Head of the Department (HoD)**.
3. Pay a **fine of ₹250 per course** via *State Bank Collect* using the following steps:
  - Navigate to: SB Collect → Educational Institutions → NIT Trichy Institution Fees → Other Fees
  - Under *Remarks*, clearly mention: "**Deregistration of V-Grade Elective Courses**"
4. **Download and retain** a copy of the **payment receipt** (in pdf).
5. **Fill out the Google Form** <https://forms.gle/aD8rhFQMNIauFmx48> and upload the scanned copies of the signed registration form and payment receipt **from 16.01.2026 to 21.01.2026**.
6. Submit the **hard copy** of the completed requisition form along with the payment receipt to the **UG Section** in the academic office **from 22.01.2026 to 23.01.2026**, during office hours.
7. Incomplete applications or those without proper approvals and valid payment receipt will not be processed.
8. **Applications for which the Google Form is not duly filled and/or the corresponding hard copy is not submitted to the Academic Office within the stipulated deadline will not be considered.** In any cases, no refund of the fee, if paid, will be processed.
