Sub: Reassessment Examination for PG-MBA / January 2024 Session – Regarding.

The Reassessment for MBA students are scheduled from 14/05/2024 to 22/05/2024. Eligibility is open to both current first year and second year MBA students who have failed (F) / absent (X) in the regular assessment held in previous sessions.

(a) Registration Procedure

- i. Log in to the Management Information System (MIS) and finalize your online registration during 09.05.2024 and 12.05.2024.
- ii. Capture screenshots confirming the registration for each individual course.
- iii. Submit the necessary fees at the State Bank of India using SB-collect.
- iv. Complete the Reassessment/ supplementary examination form provided.
- v. Combine the registration confirmation screenshots, SB-collect fees receipt, and the examination form into a single file and email it to examfees@nitt.edu by 12.05.2024, before 11 pm.

The E-mail must exclusively originate from the student's NIT-T webmail ID. The Reassessment registration request will not be handled unless there is prior online registration in the Management Information System (MIS). In the event that a student neglects MIS registration, even with fee payment, they must forfeit the fees already paid and re-register in the subsequent semester Reassessment by making the payment again.

(b) Faculty allotment

- i. After verification by the academic office, the compiled list of students will be forwarded to the respective department.
- ii. On 13.05.2024, the allocation of faculty will be carried out by department MIS Coordinators/HoDs, and students will be promptly notified. Students are advised to reach out to the assigned faculty for timely completion of assessments.
