**Dear Candidate,**

We wish to inform you that you are provisionally selected for admission to the MBA programme 2018-2020. In order to confirm the provisional admission (3rd round), you are required to pay one semester's fee as specified in the following through State Bank of India online via "SBI I Collect" on or before 8<sup>th</sup> June , 2018. The fees to be remitted is as follows

- OC/OBC – Rs. 59,600/-
- SC/ST – Rs. 24,600/- and
- SC/ST – Rs. 9,600/- (whose parental income is less than Rs. 4.5 Lakhs per annum)

**Please note the following points:**

1. Request for change in the mode of payment or extension of the dates will not be entertained.
2. You will be required to bring all the original certificates as specified below for verification and submission at the time of admission, along with the attested photo copies of all the certificates. The Admission date will be communicated shortly
  - Statement of Marks or Grades obtained in the qualifying examination.
  - Degree/Provisional Certificate.
  - Transfer Certificate.
  - Migration certificate
  - Course Certificate, Conduct and Character Certificate.
  - SSLC certificate
  - HSC certificate
  - Students who are awaiting their results should submit their degree and final year marks statements on or before 13<sup>th</sup> August, 2018.
  - S.S.L.C. or any other Certificate for proof of age.
  - Physical fitness certificate certified by a Government Medical Officer.
  - Community Certificate for candidates selected under OBC/SC/ST Category (OBC Certificate should have been issued on or after 01.04.2018 as per the norms of Central Government of India).
  - Income certificate issued by the competent authority for SC/ST candidates whose parental income is less than Rs. 4.5 lakhs per annum.
  - CAT Score Card.
3. The advance payment of one semester fee is mandatory to confirm your seat. If any candidate fails to pay their one semester fee through SBcollect within the stipulated time, his/her candidature is automatically cancelled and he/she cannot claim for admission to MBA programme.

4. Candidate provisionally selected under PWD category will have to be approved by the Medical Board as per NITT norms.

5. The SC/ST candidates whose parental income is less than Rs. 4.5 Lakhs per annum need to produce latest income certificate issued by the competent authority at the time of final admission.
