Engagement of Temporary Staff Nurse

Applications are invited to recruit Temporary Staff Nurse posts at the National Institute of Technology, Tiruchirappalli. The post is purely on a temporary basis and do not confer any right to claim either for subsequent employment or permanent posts in the future. The initial tenure of the contract appointment is six months only. The tenure of the appointment may be extended subject to the satisfactory performance of the candidate and the necessity for continued retention. The applications may be filled out through the portal <https://nittnt.samarth.edu.in/index.php/site/login>, which is mentioned on the Institute website www.nitt.edu. The position will be engaged through an outsourcing agency.

Terms and Conditions:

1. The appointment is purely temporary. The post is for a period of 6 months only.
2. The Staff is expected to work in shift duties round the clock on all days including government holidays at screening booth/s or NIT Hospital.
3. They are eligible to avail one-day leave for every completed 45 days of service and not entitled to any other benefits. They shall not be allowed any leave without the permission of the competent authority.
4. He/she should undertake whatever other tasks that may arise in order to contribute to departmental development.
5. They should follow the rules and regulations laid by the Institute administration from time to time.
6. They should adhere to the ethics and etiquettes of medical practice and should maintain the dignity and decorum of the Institute.
7. Preference will be given to the experienced candidates.

Selection Criteria: (Written Test followed by Certificate Verification and Interview)

General Instructions:

1. The applicants should go through all instructions carefully and ensure that the applicant fulfills all eligibility conditions. Their admission to all stages of the recruitment will be purely provisional, subject to satisfying the eligibility conditions.

2. Candidates should carefully fill out all the details required in the application form, including age, Educational Qualification, details of valid Community/ PwD Certificates, etc., as no correspondence regarding change of details will be entertained after the last date for applying. If any of their claims is found to be incorrect, it will lead to rejection of their candidature.
3. The prescribed essential qualifications/experience indicated are the bare minimum, and mere possession of the same will not entitle the candidate to be called for the selection process.
4. The Institute reserves the right to restrict the number of candidates called for the selection process to a reasonable limit based on qualifications, level of relevance of experience higher than the minimum prescribed in the advertisement and other academic achievements. The Institute has the right to decide the mode of screening and test the applicant for shortlisting and selection.
5. The number of vacancies indicated in the notification is tentative. The Institute reserves the right not to fill any or all posts advertised and to reject any or all applications without assigning any reason.
6. Candidates shall have to produce original documents at the time of appearing for the selection process.
7. The qualification prescribed should have been obtained from a recognized University/Institution.
8. No TA/DA shall be paid to the candidates attending the selection process except PwD candidates who are eligible to be paid up as per Institute norms.
9. Any dispute with regard to the selection process will be subject to the court/tribunal having jurisdiction over Tiruchirappalli.
10. Canvassing in any form/bringing in any influence, political or otherwise, will be treated as a disqualification for the post. **Interim inquiries will not be entertained.** If it is found at any stage that any information given in the application is incorrect/ false, the candidature/appointment is liable to be cancelled/terminated.
11. The age limit, if any, is as of **24.06.2024** (last date of application submission).
12. The selection process will be held at the National Institute of Technology, Tiruchirappalli – 620 015.
13. The appointment is liable for premature termination with One month's notice.
14. The selected candidate should undertake whatever other task may arise in order to contribute to institutional and department development.
