**Engagement of Apprentice Trainees at NIT Tiruchirappalli for the year 2026-2027**

The National Institute of Technology Tiruchirappalli invites applications for the engagement of Graduate and Diploma Apprentice Trainees across various disciplines under the provisions of the Apprentices Act, 1961, and its subsequent amendments.

This initiative aligns with the National Apprenticeship Training Scheme (NATS), a flagship program of the Government of India aimed at empowering Indian youth with industry- relevant skills in trade disciplines. The scheme provides practical, hands-on, On-the-Job Training (OJT) opportunities for Graduate, Diploma, and Vocational Certificate holders, with training durations ranging from 6 months to 1 year.

Engagement of Apprenticeship Trainees is called for **24 Vacancies** through NATS portal provided their apprenticeship forms are registered by BOAT/BOPT within 3 years from the date of passing of their final examinations (F.No 13-7/2017-TS.VII dated 17.12.2021).

At NIT Tiruchirappalli, the apprenticeship programme will span for one year for diploma holders and Graduates, offering a comprehensive learning experience. Selected candidates will receive a monthly stipend of ₹14,000/- for Diploma holders and ₹15,000/- for Graduates during the training period. The requirement is as follows:

**How to Apply:**

1. Eligible candidates can apply as below.

  - b) Click Student
  - c) Click Student Register
  - d) Complete application form
  - e) A unique Enrolment Number for each student will be generated.

After completing the Enrollment for applying,

- a) Login with email ID and password
  - b) Under "Apply against advertised vacancies"
  - c) Search "National Institute of Technology, Tiruchirappalli"
  - d) Click apply (You can see the status applied)
2. The applicant will be responsible for the authenticity of information, other documents and photographs submitted.
3. The Institute reserves the right to relax qualification and experience for the candidates with exceptional credentials.
4. Institute will follow the reservation as per GoI norms.
5. Applicants who are already in employment (Government or any other organization) are required to submit the "No Objection Certificate" from the employer at the time of interview, along with the above-mentioned documents.

6. The decision of the selection committee is final. Canvassing in any form leads to the rejection of the candidature.
7. Selected candidate will not be permitted to claim any regular/part-time appointment in this Institute or any other, during this period or later.
8. No TA/DA will be paid for attending the interview.
