#### NOTICE INVITING TENDER

The National Institute of Technology, Tiruchirappalli (NITT) is an autonomous body under MHRD, GOI, imparting Technical Education and engaged in Research Activities. It is proposed to procure the following component for the departmental academic/research activities.

Sealed Quotations under *two cover system* are invited for the following component subject to the following terms and conditions, from the reputed manufacturers or their authorized dealers so as to reach this office on or before scheduled date and time. The technical cover will be opened on the same day in the presence of bidders or their authorized agents who may choose to be present.

#### SECTION 1: INSTRUCTIONS TO BIDDER

1. The bidder should give details of their technical soundness and provide list of customers of previous supply of similar items to Universities, Institutes or Government Departments/Undertakings/public sectors with contact details. The details of the agency/profile should be furnished along with the copy of all related documents.

#### 1.1 Bids are to be submitted under two cover system.

#### Cover 1:

The cover 1 shall be superscribed as 'Technical cover' duly indicating the Tender reference No. and the due date of opening for the supply of "PRAGYAN– 2012/ ROUND-NECK T-SHIRTS and COLLAR NECK T-SHIRTS"

#### Cover 1 should contain the following:

- EMD Earnest Money Deposit (EMD) is to be remitted by way of Demand Draft drawn on any Nationalized bank in India by Demand Draft drawn on any scheduled bank in favour of "The Director, N.I.T., Trichy" payable at Trichy should be submitted. EMD shall bear no interest. Any bid not accompanying with EMD is liable to be treated as non-responsive and rejected.
- b. Technical pamphlets
- c. Detailed technical specification
- d. The agency should furnish copy of license certificate for manufacture/supply of the item.
- e. The agency should furnish Income Tax PAN number
- f. Remedy for defective items should be specified
- g. Duly filled up technical questionnaire, if any
- h. Duly filled up deviation schedules to technical specification
- *i.* Copy of supply orders completed during the last three years ending 31-05-2011.
- j. If the prices are revealed in the cover 1, the offer will be summarily rejected

#### 1.2 <u>Cover 2:</u>

#### The cover 2 shall be superscribed as 'Price cover' duly indicating the Tender reference No. and the due date of opening for the supply of "PRAGYAN– 2012/ ROUND-NECK T-SHIRTS and COLLAR NECK T-SHIRTS"

Cover 2 should contain the price schedule as per Section 4.

Each cover shall be sent in a double sealed cover. The inner covers (Cover 1 and Cover 2) should be sealed individually with the seller's distinctive seal and superscribed with the tender reference no. and due date of opening. Both the inner covers shall be placed in a common outer cover which shall also be sealed with seller's distinctive seal and superscribed with the tender reference no. and due date of opening.

Mention "Kind Attention: Dr. G. Kannabiran (Dean, R&C), Convener (Pragyan 2012)", and submit at the address given in the Notice Inviting Tender.

### Cover 1 will be opened on the scheduled date and time of opening. Cover 2 will be opened on the next day in the presence of qualified bidders who choose to be present.

The Institute reserves the right to place the supply order either for Round neck T-shirts or Collar neck T-shirts according to the need of this Institute. One sample each for Small, Medium, Large and Extra-Large size of men's round neck type T-shirts should be produced on the date of opening (i.e.18.1.2012 at 3.30 p.m.) of Tender (NITT/PRAGYAN/2012/T-Shirt) by the bidder, failing which the bid will be summarily rejected.

- 2. The agencies should submit their rate as per the format given in Section 4 of the Notice Inviting Tender in this cover. Rate should be quoted in Indian Rupee. The rate should be quoted both in words and figures. All the pages of the bid should be signed affixing the seal. All corrections and overwriting should be initialed.
- 3. The tender will be acceptable only from the manufacturers or its authorized supplier.
- 4. The bid shall be in the format of price schedule given in Section 4. The contract form as per format given in section 5 shall be submitted. Incomplete or conditional tender will be rejected.
- Details of quantity and the specifications are mentioned in Section 3 appended to this Notice Inviting Tender.
- 6. The item to be used is strictly according to the specification and subject to test by the Institute/concerned authorities. It must be delivered and installed in good working condition.
- 7. The Institute reserves the right to cancel or reduce the quantity included in the schedule of requirements at any time after acceptance of the tender with a notice. The Contractor/Supplier shall have no claim to any payment of compensation or otherwise whatsoever, on account of any profit or advantage which he might have derived from the execution of the work/supply in full but he did not derive in consequence of the foreclosure of the whole or part of the works.
- 8. **<u>Release of EMD</u>**: The EMD shall be released after finalization/release of the Purchase order.
- 9. <u>Validity of bids</u>: The rate quote should be valid for a minimum of 90 days. No claim for escalation of rate will be considered after opening the Tender.
- 10. <u>Imports</u>: In case, goods are to be imported, the Indian agent should furnish authorization certificate by the principles abroad for submission of the bid in response to this Notice Inviting Tender.
- 11. <u>Clarification of Tender Document</u>: A prospective bidder requiring any clarification of the Tender document may communicate to the contact person given in this notice inviting tender.
- 12. <u>Amendment of tender document</u>: At any time prior to the last date of receipt of bids, Institute may for any reason, whether at its own initiative or in response to a clarification requested by prospective bidder, modify the Tender document by an amendment.
- 13. The Institute may at its own discretion extend the last date for the receipt of bids.
- 14. The bids shall be written in English language and any information printed in other language shall be accompanied by an English translation, in which case for the purpose of interpretation of the bid, the English translation shall govern.
- 15. The Institute reserves the right of accepting any bid other than the lowest or even rejecting all the bids without assigning any reasons therefor. The decision of the Institute Purchase Committee is final in all matters of tender and purchase.
- 16. The bidder should give the following declaration while submitting the Tender.

I/we have not tampered/modified the tender forms in any manner. In case, if the same is found to be tampered/modified, I/we understand that my/our tender will be summarily rejected and full Earnest Money Deposit (EMD) will be forfeited and I/we am/are liable to be banned from doing business with NIT, Trichy and /or prosecuted.

- 1. The rates should be quoted in Indian Rupee F.O.R. NIT, Trichy for supply within India.
- In case of import both CIF and / or FOB rate should be quoted. All components of expenditure to arrive at Chennai need to be explicitly specified.
- 3. The bidder shall indicate the excise duty exemption for the goods if applicable
- 4. The Institute is eligible for customs duty and excise duty exemption.
- The rate quoted should be on unit basis. Taxes and other charges should be quoted separately, considering exemptions if any.
- 6. Rate quoted should be inclusive of Transport charges.
- 7. <u>Payment</u>: No advance payment will be made. Payment will be made only after the supply of the item in good and satisfactory condition and receipt of performance security by supplier. In case of imports, the payment will be made through LC after installation and performance security need to be submitted at the time of LC commitment.
