- 1.3 The covers (Cover 1 & 2) should be sealed individually with the bidder's distinctive seal and superscribed with the tender reference number and due date of opening. Both the inner covers shall be placed in a common outer cover which shall also be sealed with bidder's distinctive seal and superscribed with the tender reference no. and due date of opening.

1.4 <u>Cover 1 will be opened on the scheduled date and time mentioned in the tender enquiry.</u> <u>Cover 2 of the technically suitable offers alone will be opened on a date which will be intimated to the qualified bidders.</u>

- 1.5 The agencies should submit their rate as per the format given in Section 4 of the Notice Inviting Tender in this cover. Rate should be quoted in Indian Rupee. The rate should be quoted both in words and figures. All the pages of the bid should be signed affixing the seal. All corrections and overwriting should be initialed.
- 1.6 The tender will be acceptable only from the body builders.
- 1.7 The bid shall be in the format of price schedule given in Section 4. The contract form as per format given in section 5 shall be submitted. Incomplete or conditional tender will be rejected.
- 1.8 Details of quantity and the specifications are mentioned in Section 3 appended to this Notice Inviting Tender.
- 1.9 The item to be used is strictly according to the specification and subject to test by the Institute/concerned authorities.
- 1.10 The Institute reserves the right to cancel or reduce the quantity included in the schedule of requirements at any time after acceptance of the tender with a notice. The Contractor/Supplier shall have no claim to any payment of compensation or otherwise whatsoever, on account of any profit or advantage which he might have derived from the execution of the work/supply in full but he did not derive in consequence of the foreclosure of the whole or part of the works.
- 1.11 Performance Security of 5% of the contract value in terms of Bank guarantee by scheduled banks shall be given by the successful bidder for the total period of warranty.
- 1.12 Release of EMD: The EMD shall be released after receipt of performance security from successful bidder.
- 1.13 Validity of bids: The rate quote should be valid for a minimum of 90 days. No claim for

escalation of rate will be considered after opening the Tender.

- 1.14 Clarification of Tender Document: A prospective bidder requiring any clarification of the Tender document may communicate to the contact person given in this notice inviting tender.
