   The proposal for constructing of the Micro compost plant at an estimated cost of Rs. 0.50 crores was approved.
- ii. Construction of uniform compound wall around the Beryl Hostel (Converted to Girls Hostel).

The proposal for construction of uniform compound wall around the Beryl Hostel at an estimated cost of **Rs. 1.46 crores** was approved.

iii. Leakage of folded plate roof in the Chemical Engineering
Department and the Main Canteen.

The proposal for providing the galvalume sheets supported by steel structures over the folded plate roof in the Chemical Engineering Department and the Main Canteen at an estimated cost of **Rs. 0.50 crores** was approved.

- iv. Annual Maintenance Contract for Civil and Electrical works.

  The proposal for Annual Maintenance Contract for Civil and Electrical works at an estimated cost of Rs. 6.00 crores was approved.
- v. Providing Centralized Air-condition system in BARN Hall, A2, A11, A12, A13, TEQIP office in the ground floor and first floor of the administrative building.

### ITEM NO. 4 OTHER ITEMS FOR APPROVAL.

i. Delegation of financial power to the Director, NITT.

As per Rule 133 (1) of GFR 2017, "A Ministry or Department at its discretion may directly execute repair works estimated to cost up to Rs. Thirty Lakhs after following due procedure indicated in Rule 139, 159 and 160"Accordingly the B&WC recommended to increase the delegation of financial powers of the Director from Rs. 10 lakhs to Rs. 30 lakhs.

ii. Arbitration amount claimed by the CPWD.

The matter regarding arbitration amount of **Rs.** 7 **crores (appx)** including interest per annum claimed by the CPWD was discussed and the Committee advised to refer the matter to MHRD.

iii. Registration of contractor agencies for small construction and repair works.

The proposal for Registration of contractor agencies for small construction and repair works was approved.

iv. Progress report of various construction works entrusted to CPWD.

The proposal for Progress report of various construction works entrusted to CPWD was approved.
